Eleven candidates will interview for the Firefighter/Engineer position on October 4 and 9.

Scott moved the Jim Tavernas be removed and that Bart Muller be added as an authorized signer on all district accounts. Swart seconded the motion and the motion carried.

It was the consensus of the Board that the January, 2019 meeting be held on January 8 instead of January 1.

Swartz moved that the Board move to closed session. Muller seconded the motion and the motion carried.

Swartz moved that the Board move to open session. Haringa seconded the motion and the motion carried.

Chairman DeSouza reported the Board unanimously agreed during closed session to allow Chief Mundello's request to open a fifth captain's position.

Chief Mundello thanked the Commissioners for their help at the Deep Pit BBQ which was held Saturday, September 8. Modesto Junior College has requested that Denair Fire Department provide medical coverage for their football games. Covenant Village brought a group of residents for a station tour.

The meeting was adjourned at 8:27 p.m.
