Rosenbauer will provide training on the new Type 1 engine on Wednesday, April 3.

Haringa moved that Rescue #84 be offered for sale for \$199,000 on Equipment Trader, Craigs List and the Denair Fire website. A "for sale" flier will posted at the fire station, post office and community service district and emailed out to other fire districts. Up to \$100 can be spend to advertise the sale. Swartz seconded the motion and the motion carried. Scott voted no.

Sale of the old #23 has been postponed until a later time.

Scott moved that 75% of the Strike Team Admin Fee be paid to the Strike Team Coordinator(s). The remaining 25% of the Admin Fee as well as the entire Apparatus Reimbursement Fee will remain with the district. Swartz seconded the motion and the motion carried. An amended Strike Team Funds Board Policy will be presented at the May meeting for approval.

Muller moved that the Cal OES Strike Team Task Force Leader Manual be adopted as the District SOP. CAL OES updates to the manual will be adopted by the District as they are released without further vote. Swart seconded the motion and the motion carried.

The Handbook/SOP Committee is currently compiling OSHA required policies.

The air conditioning on #57 was repaired by NVB at a cost of \$436.67.

Scott moved that up to \$18,000 in Special Assessment funds be spent to outfit the new #23 in order to get it into service as soon as possible. Muller seconded the motion and the motion carried.

The Violence in the Workplace Policy and the IIPP were reviewed by the board.
