Swartz moved that the district defer Firefighter Jose Ramirez' Walker Fire strike team wage deduction until the strike team funds are received by the District. Ramirez will sign a note acknowledging the \$851.39 payroll advance. Scott seconded the motion and the motion carried.

Chief Mundello is collecting bids to repaint the exterior of the fire station and to pressure wash and possibly coat the roof. Donations will be solicited to fund the project.

The Board requested that Jeff Hopper of Lexipol present an online demo of their policies/procedures service via computer at the November meeting.

Joe Spani is using the station to teach an Operator 1B class in exchange for some free spots in the next 1A class for Denair volunteers. Denair Preschool toured the station on Friday, September 27.

The meeting was adjourned at 7:03 p.m.
