Muller moved that the IIPP and COVID 19 Supplement be adopted as presented. Scott seconded the motion and the motion carried.

The 2018 and 2019 audit report was distributed to the commissioners.

Scott moved that the Special Assessment tax rate be increased 2% for 2020-21 and that the Signature Sample be accepted as presented. Muller seconded the motion and the motion carried.

Scott moved that the preliminary 2020-21 budget be approved as adjusted. Swartz seconded the motion and the motion carried.

Swartz moved that the Board move to closed session. Scott seconded the motion and the motion carried.

Swartz moved that the Board move to open session. Muller seconded the motion and the motion carried.

No votes were taken during closed session

The meeting was adjourned at 8:06 p.m.
