Chief Mundello will attend an online meeting with Lexipol on October 6, 2021.

Scott moved that the Cascade Fire Equipment bid for a Type 6 Fire Engine be accepted at a total cost of no more than \$210,000. Developer Funds and Special Assessment Funds will be used for the purchase. Muller seconded the motion and the motion carried.

Paying firefighters to staff the station during business hours when the paid firefighter is absent was discussed. A job description is currently being drawn up.

Muller moved that the words "totaling no more than twenty-eight days per year" be removed from Section 8a and that section 8c. "The station will be unmanned during the employee's strike team leave." be deleted completely from the Conditions of Employment for the Full-Time Firefighter/Engineer. Scott seconded the motion and the motion carried.

Muller moved that up to \$3,500 be approved for the purchase of new tires, shocks and airbags for U38. Chief Mundello has obtained bids and will be responsible for the purchase. Scott seconded the motion and the motion carried.

The District website will be discussed at the November meeting.

Scott moved that \$110,000 be transferred from the General Fund to the Westamerica Checking. Haringa seconded the motion and the motion carried.

Scott moved that the Board move to closed session. Muller seconded the motion and the motion carried.

Haringa moved that the Board move to open session. Scott seconded the motion and the motion carried.

Swartz reported that the Board voted to increase the Board Clerk stipend to \$1,500 per month effective October 1, 2021.

The Volunteers will be sponsoring a toy drive for Christmas.

The meeting was adjourned at 8:04 p.m.
